PROGRAMA

I- Objetivo do Curso

O objetivo deste curso é discutir os principais tópicos que têm constituído os blocos formadores do conhecimento antropológico sobre as sociedades indígenas africanas (abaixo do Saara). Devido a enorme dimensão territorial do sub-continente, a profundidade histórica das sociedades que ali se encontram e a variabilidade sócio-cultural, deixamos propositalmente de lado as questões relativas ao encontro intersocietal entre africanos e outros povos (europeus, povos islamizados do norte da África e da Ásia, indianos e malásios) e os temas decorrentes deste fato histórico (colonialismo, os estados-nações africanos e outros). O modo pelo qual este curso está organizado pressupõe a idéia de que, por trás das diferenças aparentes entre as sociedades africanas do presente, há, num nível básico, uma uniformidade subjacente às culturas do sub-continente, algo que se poderia chamar de ecuménio africana.

II- Organização do curso e bibliografia

O curso terá a forma de discussões temáticas organizadas em torno das leituras realizadas para cada sessão. O instrutor atuará como condutor e sistematizador da discussão, que será centrada na leitura dos textos e nas questões trazidas pelos estudantes. Recomenda-se que os estudantes escrevam pequenos textos (não maiores que cinco páginas cada) que sintetizem as principais conclusões de cada unidade do curso.

A avaliação será feita com base num trabalho final que tomará a forma de uma resenha de dois ou mais textos constantes das partes III e IV deste programa.

A bibliografia apresentada nesta seção do programa é de leitura obrigatória, excetuando-se os títulos marcados por **, cuja leitura é, no entanto, altamente recomendável.
